Inmate [REDACTED] is being reviewed for a subsequent hearing. He currently has an OPBS of 2 with non-discretionary override code of H (loss of life). He did not receive any D-Reports in the last 12 months. At this time he is living and working in unit [REDACTED] and he receives good housing/employment evaluations from the unit Officer. He currently is not participating in any formal programming, but he is on the waitlist for the Reentry workshop. Program plan was reviewed with the inmate. Industries eligible.

Addendum: parole denied with a 1 yr set back (the Board also recommended he do Criminal Thinking). Override for criminal thinking has been approved and Spectrum has been notified about prioritizing his enrollment based on parole decision. JG 1/18/23

Prior Incarceration Summary

crime, subject fled to [REDACTED] where he remained for nearly a year before being arrested as a Fugitive from Justice and extradited back to MA via the Charles Street Jail. He awaited trial for 276 days. Records reflect 5 RTHC, 2 parole failures and more than 15 d-reports.

On 04/26/76, he was sentenced and committed to MCI-CJ where he remained until 11/01/76 when he was transferred to the RDC for classification purposes. On 11/17/76, he was returned to MCI-CJ as a result of his sentence structure.

On 07/14/77, he transferred to MCI-Norfolk. He maintained a variety of employment positions and was actively involved in programming. He did incur 5 d-reports for (2) smoking Marijuana, being out of place, lying and refusing to move. He incurred a d-report in 11/81 for refusing to move to NCCI and was transferred to MCI-CJ on 07/21/81.

On 09/18/81, he transferred to MCI-Norfolk and after a period of positive adjustment he was transferred to a BSCC minimum on 07/11/83.

Subject successfully adjusted to minimum security and during that time he held numerous employment positions and completed a number of successful furloughs. He was returned to MCI-Concord in 11/08/87 after he incurred a d-report for refusing to leave the visiting area.

Following his return, he transferred to MCI-Norfolk on 01/20/88 where he successfully worked his way to minimum security on 05/18/88 via NECC. He was transferred to the PDPRC in 08/21/89 and remained in this status until 03/10/90 when he was returned to MCI-Concord after he was fired from his employment position at [REDACTED]

Subject remained at MCI-Concord for over 1 year. He was returned to minimum status at NECC in 06/29/90 and was subsequently transferred to the THP on 10/10/90 and subsequently to the Brooke House in 11/24/90. He was paroled 01/18/91.

On 03/25/91, he was returned to B.C.C. as a Parole Violator. His parole was revoked following new arrests for OUI and Possession Cl. B and Cl. D. He remained housed at that facility for 4 days before he was returned to MCI-CJ on 03/29/91 after he incurred 2 d-reports for threats and refusing a move.

On 08/16/91, he transferred to OCCC and he remained at that facility until 05/01/92 when he was transferred to NECC.

On 11/15/92, he was returned to MCI-Concord following an altercation with 2 officers as he was attempting to flush \$50.00 down the toilet. On 01/14/93, he was subsequently transferred to MCI-CJ and remained there for 6 months before he was transferred to NCCI in 08/27/93.

On 01/06/95, he was transferred to MCI-Shirley minimum where he displayed a positive adjustment resulting in a transfer BSPRC on 08/01/96. On 02/03/97, he was released on parole from this facility. His parole was revoked in 12/03 and returned to MCI-Concord on 10/19/04 as a result of a new arrest for Armed Aslt w/intent to Murder (received an 18-20 yrs cc. "B" sentence). While residing at MCI-Concord, he held a job assignment from 11/04 until 03/05 at

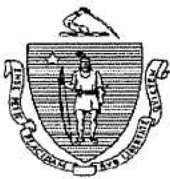
